
Piedmont Advantage recognized as a BEST PLACE TO WORK

Fraud Alert Spotlight: Tech Support Scams

Fraudsters are increasingly savvy. They find about you through social media and other platforms to gain access to your hard-earned money.

Piedmont Advantage's fraud department monitors and investigates transactions for potential fraudulent activity and warns tech support scams remain popular among fraudsters.



For example, if you get a computer screen pop-up claiming something like the following, think twice before acting: "To avoid a \$300 tech support renewal fee charge to your account, click the following link or call the following number to cancel your automatic renewal."

If you click the link or call the number, the fraudster will attempt to gain access to your account information.

Three Tips to Avoid Fraudsters

- Don't respond to computer screen pop-ups, emails or calls asking you to take action to avoid fees or something similar unless you initiate the request.
- 2. Beware of all solicitations asking for your passwords, PINs and checking and credit card information. We would never ask you to share sensitive information over the phone or by email without your request.
- 3. Use electronic statements when the option if available as paper statements are easy to intercept from your mailbox. Our eStatements are password protected and only accessible when you log into Advantage Access Online Banking.
